

## AN ORDINANCE

To place upon the City Plan certain streets, alleys and courts in the Fifth, Sixth, Seventh and Eighth Wards, opened and in public use prior to June 6th, 1871.

SECTION 1. *The Select and Common Councils of the City of Philadelphia do ordain*, That the Department of Public Works be, and the same is hereby authorized to place upon the City Plan the following streets, alleys and courts in the Fifth, Sixth, Seventh and Eighth Wards, of the width as opened and built upon prior to June 6th, 1871: Discount place, from Sixth street westward, north of No. 30 North Sixth street; Philip street, from Lodge street northward, east of 219 Lodge street; McMullen's court, from Walnut street northward, east of 415 Walnut street; McKean's court, from Locust street southward, east of 610 Locust street; Lawrence street, from Locust street northward, east of 421 Locust street; Leithgow street, from Locust street northward, east of 413 Locust street; Fairhill street, from Locust street southward, west of 526 Locust street; George court, from Sansom street northward, 120 feet west of Sixth street; Lawrence street, from Library street southward, west of 416 Library street; Sheridan street, from Barclay street to Middle alley, west of 626 Barclay street; Howard street, from Lombard street northward, east of 113 Lombard street; Addison street, from Hicks to Mole street, 70 feet north of Lombard street; Hicks street, from Stone to Addison street, 100 feet west of Fifteenth street; Mole street, from Stone to Addison street, 66 feet east of Sixteenth street; Panama street, from Filmore street eastward, 62 feet south of De Lancy street; Watts street, from Lombard street southward, west of 1340 Lombard street; Addison street, from Twenty-second street to Albion street, south of 409 South Twenty-second street; Goodwin alley, from Goodwater street southward, 126 feet east of Eighth street; Osborn court, from Duponceau street westward, 90 feet south of Walnut street; Moravian street, from Ninth street westward, south of 130 South Ninth street; Essex street, from Prosperous street eastward, south of 231 Prosperous street; Manning street, from Thirteenth street to Dean street, 86 feet north of Spruce street; Marble court, from Walnut to Juniper street, east of 1336 Walnut street; Tin alley, from Locust street northward, 130 feet east of

Broad street; Arrison court, from Fifteenth street westward, north of 114 South Fifteenth street; Latimer street, from Juniper street eastward, 110 feet south of Locust street; Heberton street, from Twenty-first street westward, north of 226 South Twenty-first street; Mullooney street, from Twenty-first street eastward, north of 237 South Twenty-first street: *Provided*, That satisfactory evidence be furnished that the said streets, alleys and courts were opened and in public use prior to June 6th, 1871.
